

# 2024 Permanent Tee Time Contract

**PERMANENT TEE TIME DATES & FEES:** Permanent Tee Times for 2024 will begin on March 30<sup>th</sup> and 31<sup>st</sup> and conclude on September 28<sup>th</sup> and 29<sup>th</sup>. Permanent Tee Times are limited to 6 Players per group. The fee for a Permanent Tee Time is \$380 per person (\$1,520 per Group). Discounted Green Fees for the 2024 season will be \$100 per player for non-residents and \$86 for Vernon Hills residents, including the golf cart. Dynamic Pricing for non-PTT players' tee times will be higher.

**PAYMENT OF PTT FEES:** A non-refundable deposit of \$380 per Group and a signed contract is due by Saturday, December 23, 2023, to hold a time for the 2024 season. If a deposit is not received by Saturday, January 13, 2024, your time will be released. Final payment for the Group and completed application forms from each player are due by February 1, 2024. All fees associated with Permanent Tee Times are non-refundable.

**TEE TIME CANCELLATION PROCEDURES:** The Group is required to pay 4 green fees each week. The entire Group may cancel a minimum of 7 days in advance in writing or by email without charge. If a Group cancels less than 7 days in advance, the White Deer Run staff will attempt to fill the time. If the time is not filled, each player in the group will be charged the appropriate green fee. If an individual player needs to cancel, the golf staff will try to fill the spot; but if the staff is unable to fill the slot, the green fee will be charged to the player's credit card. Individuals or Groups who do not show up for their appointed permanent tee times and have not properly followed these cancellation procedures will be charged the appropriate green fees.

**INCLEMENT WEATHER:** In the case of rain, White Deer Run may release the obligation of the Group for that day. If inclement or dangerous weather has interrupted play and play cannot continue, players in the Group will be eligible for a rain check under the White Deer Run Rain Check Policy. In all cases, decisions by the White Deer Run Golf Club staff concerning the playability of the golf course are final.

**SLOW PLAY:** Each PTT Group is responsible for maintaining proper pace of play. Expected pace is 4 hours' contingent on weather and other conditions. A written warning will be sent to a Group that has not kept pace. After the second warning, any other infractions may result in moving the Group to the final tee time on Saturday or Sunday.

**OUTSIDE FOOD & BEVERAGE:** Due to Health Department and Alcohol Beverage Control Laws and Regulations, all food and beverage products MUST be purchased, prepared and served by the Club staff. White Deer Run Golf Club, LLC is committed to a policy of providing legal, proper and responsible hospitality. White Deer Run Golf Club, LLC reserves the right to refuse to serve or to terminate the service of alcoholic beverages at any time.

**GENERAL:** Each permanent tee time player shall be responsible for any damage to White Deer Run Golf Club, LLC caused by the conduct of any participant or participants in the Group. White Deer Run Golf Club, LLC reserves the right to cancel any permanent tee time, without refund, if the Group does not adhere to club policies. White Deer Run Golf Club, LLC shall not be responsible if it is unable to fulfill its obligations under this contract due to government actions, strike, fire, flood or other emergency conditions beyond the reasonable control of White Deer Run Golf Club, LLC.

**As Group Captain, I hereby agree for my Group to the terms set forth in this White Deer Run Golf Club Permanent Tee Time Contract. I also agree to inform the members of my Group of the provisions of this Contract and each player authorizes White Deer Run Golf Club, LLC to charge the appropriate green fee to the credit card number of any player who does not show up for a tee time.**
